Our schools should be sanctuaries for learning. Sadly, violent episodes are commonplace in classrooms across the country. To compound this issue, the scourge of mass shootings continues to infiltrate our schools. We must push our leaders to take action on behalf of our schools and communities.

Part of NYSUT's core mission is to advocate for safe environments for our students and better working conditions for our educators and school staff. We believe that safe, secure, welcoming school environments are essential for effective teaching and learning. Therefore, we must act — and act quickly — to address this current and escalating crisis of safety in our schools.

In addition to the immediate actions and advocacy that NYSUT and our national unions are engaged in in Albany and in Washington, NYSUT is launching a new Safe Schools for All Task Force to hear from our

members on this topic and get your input on next steps. The Task Force is charged with building a list of recommendations for how our state and districts can best support safe public schools at the center of every community. We will focus on several key areas most crucial to building safer school environments:

Addressing Social-Emotional Needs of Students — The social-emotional impacts of the pandemic have led to increased incidences of students acting out, classroom disruption and violence. We must focus on supporting and lifting up our students to root out behaviors that can lead to this disruption and violence. Relying solely on punitive measures will only harm our students in the long run and exacerbate the very problems we are seeking to solve. Properly addressing social-emotional needs is one of the best ways to prevent future acts of violence in our schools.

**Ensuring Appropriate Staffing Levels** — School staff already are stretched too thinly, to say nothing of the physical injuries and mental health impacts stemming from fights, threats and other forms of disruption. School staffing levels must meet the level of needs. We need more school counselors, school psychologists, social workers, school attendance teachers, resource officers and other support staff. By adequately staffing our schools, we can ensure that all staff should have appropriate caseloads that allow them to focus on preventative work with students.

**Fostering Community Partnerships** — Schools do not stand alone as islands in our society. Rather, our schools are integral and active parts of our communities. School-community partnerships must be an important part of developing safe and vibrant schools in all of our communities.

Confronting the Crisis of Mass Violence in Schools — For far too long, schools have been the sites of mass-murder events. The list of schools and towns made infamous by mass shootings is long and grisly. Our educators are thrust on the front lines to help students and families process horrific events, while simultaneously trying to cope with the unthinkable themselves. No student, educator or parent should live in fear of this scourge infecting their communities. This ongoing violence, and the profound threat it poses to the lives and learning of our children, is a national embarrassment that must end.

The Task Force will begin meeting this summer (via zoom) to begin this important work. If you are interested in joining us, please contact Melissa Servant. Our meetings will be starting soon. You can join from the comfort of your home or by the pool, at the beach or from your campsite!

## Supreme Court decision funnels taxpayer dollars to private religious schools NEA Becky Pringle's statement:

"All students, no matter where they are from or live, deserve access to a great public school. The public education system remains one of our most powerful institutions for maintaining a democratic society and fostering common understanding among our people. With its radical ruling in *Carson v. Makin*, the Supreme Court has once again undermined public schools and the students they serve in favor of providing funding for private religious schools that serve only a few and often discriminate against students and employees. Forcing American taxpayers to fund private religious education — even when those private schools fail to meet education standards, intentionally discriminate against students, or use public funds to promote religious training, worship, and instruction — erodes the foundation of our democracy and harms students. "The Supreme Court's job is to interpret the Constitution, not invent doctrines to promote radical education policy outcomes. We are witnessing one of the most extreme Supreme Courts in modern history rewrite the most basic social commitments of our society — that publicly-funded education should be free and open to all without discrimination is one of those commitments. Shamefully, today's decision tosses aside that social commitment."

# Hearing Aid Reimbursement Benefit offered by Wallkill Teachers' Association Benefit Trust Effective 3/1/2022

#### The Benefit

The plan provides hearing aid benefits once every 5 years for you and your eligible family dependents when you receive care from a licensed and certified audiologist. It must be medically substantiated that an aid is required.

The Plan will reimburse charges up to the maximum of \$500 towards the cost of a hearing aid.

The Plan may be used in conjunction with the *Amplifon Hearing Care* (888-432-7464) discount program through Delta Dental.

#### What You Need to Do

Obtain a referral from your physician or certified audiologist for you or your dependent's hearing exam.

60 days after receiving the aid/device, submit a Hearing Aid Reimbursement Benefit Form to the WTA Benefit Trust for reimbursement of eligible expenses.

Only original paid receipts or bills (NO photocopies) will be considered acceptable documentation.

#### What is NOT Covered

- Amplifiers
- Battery or parts replacements for hearing aid/device
- Hearing Exam (use other medical insurance for that expense)
- Repairs to hearing aid/device
- Lost, damaged, stolen hearing aid/device
